2025 PEBTF Open Enrollment

October 20 to November 7, 2025 For Medicare-Eligible Retirees and COBRA Members

Your Retired Employees Health Program (REHP) Aetna Medicare Open Access PPO and the SilverScript Prescription Drug Plan continue for 2026.

For 2026:

- Copays your copays remain the same. You pay \$20 to see your primary care physician (PCP) and \$30 to see a specialist.
- Deductible your Aetna Medicare Open Access PPO annual deductible may change, as it is based on the Medicare Part B 2026 deductible. Aetna will send you a notice when that information is available.
- Providers see any health care provider or hospital, as long as they are eligible to receive Medicare payments and are willing to bill and accept payment from Aetna. No referrals are needed to see specialists.
- Medicare Part B premium the premium, which is deducted from your Social Security check if you collect Social Security benefits, is subject to change each year.
- Prescription drug SilverScript, an affiliate of CVS Caremark®, continues as your Medicare Part D prescription drug plan. The copays remain the same for 2026. For more information visit www.pebtf.org or rehp.silverscript.com.

Do I need to take any action?

- You do not need to do anything. You will continue to be enrolled in Aetna Medicare Open Access PPO and the SilverScript Prescription Drug Plan offered by the REHP in 2026. Do not enroll in another Medicare plan, whether through Aetna or another carrier.
- You may remove dependents from your coverage who do not have a qualifying event (i.e., divorce, other coverage, etc.). That change would be effective January 1, 2026.

You may opt out of REHP benefits. If you opt out, you will need to enroll in other medical and prescription drug coverage outside of the REHP. In addition, you are only allowed one opportunity to re-enroll in REHP benefits once you have opted out. See page 4. If you have a family member enrolled in your benefits who is not eligible for Medicare, you will also receive a Non-Medicare Open Enrollment Newsletter. The Non-Medicare Open Enrollment is being held **October 13 to October 31, 2025**. SilverScript Prescription Drug Plan

The Medicare Prescription Payment Plan continues for 2026. You can make monthly payments throughout the year instead of paying for the total cost of the prescription at the pharmacy. The payment plan may be beneficial for members who take high-cost prescription drugs. If you take lower-cost medications or generic drugs, you would continue to pay low copays at the pharmacy and may not be interested in a payment plan.

Your REHP Medicare Benefits

You are enrolled in the Aetna Medicare Open Access PPO and SilverScript Prescription Drug Plan, which is a Part D plan. These plans offer comprehensive health benefits, plus additional health and wellness programs.

You may ignore mailings from other Medicare Advantage and Part D prescription drug plans. Because you have All Medicare-eligible members are receiving this newsletter. If you are turning 65 between now and April 30, 2026, you are also receiving this newsletter so that you can read about the medical plan that will be offered to you as a Medicare-eligible member.

comprehensive coverage under the REHP, there is no reason for you to enroll in any other plan. If you enroll in another Medicare Advantage or prescription drug plan you will be opted out of the REHP. If you opt out of your REHP coverage, either intentionally or unintentionally, it can be reinstated one time only, unless it was previously canceled because of re-employment by the Commonwealth and subsequent coverage under the Active Employees Health Program or a State Police Program.
